This form must be used by all international applicants from countries outside EU/EEA and Switzerland who are either applying directly from abroad, or who have a temporary (not permanent) residence permit in Norway (Application deadline: 15 January 2024), and applicants who are citizen of countries within EU/EEA and Switzerland (Application deadline: 15 April 2024). This form must be uploaded as document no 1 with your online application. Educational consultancies or agents, or any other third party/ person, cannot fill in this form, apply for admission or upload any documents on behalf of individual applicants at HiMolde. First read the documentation requirements under "Application Procedures" very carefully before filling in this additional application form, and before you start uploading any of your application documents. Molde University College - Specialized University in Logistics (HiMolde) is under no obligation to process applications which are not complete or which are lacking any of the required documentation. HiMolde will verify the educational documents, either in connection to the application process or alternatively shortly after the admitted students have arrived in Norway/Molde.

When filling in your names and personal data in the online application portal: Please give your names as they appear in your PASSPORT. For the sake of file-keeping it is essential that only one family name is given. If, however, you have two family names (e.g. maternal and paternal family name), please use the one used more frequently or considered the most «important». Use the name (s) consistently throughout all correspondence with HiMolde. Regarding Norwegian personal (ID) number: Norwegian citizens and foreign citizens from countries outside EU/EEA residing in Norway for more than 6 months already have or will usually obtain a personal Norwegian ID-number. International students receive such a number upon application to the Taxation Office about 3-4 weeks after their first arrival in Norway. The group of applicants from countries outside EU/EEA, having a temporary residence permit in Norway, is still considered as "International Applicants" at HiMolde, and should register their application as such in the application portal / "Søknadsweb". They must also meet all the financial requirements under document 9.

VI Additional documentation requirements for applicants from some countries outside EU/ EEA.

These documents must be sent directly by post to Molde University College – Specialized University in Logistics (HiMolde) at latest by 1 March 2024 (last postal/sending deadline):

- For international applicants who are not exempted from the formal English Language Requirements, a recognized English Language Proficiency test must be sent directly from e.g. the respective TOEFL centre or British Council test centre where the test has been taken. HiMolde's TOEFL institutional code is D571. In addition, the applicants who have completed one of these recognized tests within the application deadline: 15 January 2024, must upload a copy of the original test result or alternatively the registration form from the test centre, showing that they will take the test in good time before 1 March 2024, as document 5 in the check list when applying. For verification reasons the TOEFL or IELTS test or other recognized English test results must not be older than two years (not older than 1 March 2022 for admission in 2024, preferably a newer test taken in 2023).
- Pearson PTE Academic Test must be sent online from the Pearson secure online portal to Molde University
 College Specialized University in Logistics (HiMolde). If you need, you can also use the email address of Odd
 Arne Eidem: odd.a.eidem@himolde.no. Please remember to mark your result with your application number
 when sending the test result online. Last deadline for submitting the Pearson PTE Academic test: 1 March 2024
 (Applicants from countries outside EU/EEA and Switzerland), and 15 April 2024 (Within EU/EEA).
- *Applicants who have completed their degrees from P.R. of China, must submit an application to CSSD (Centre for Student Services and Development, under the Chinese Ministry of Education (MOE). The documents (verification reports for both degree certificates and transcripts from CSSD) must be uploaded to the application portal within 15 January 2024, together with all the completed degree diplomas and transcripts from the educational institution where the education has been taken. In addition to the verification reports from CSSD, all applicants from P. R. of China must document educational documents mentioned under document 4, and all these documents must be sent latest within 1 March 2024 directly to HiMolde as a hard copy by post for the application to be followed up (see also below).
- **Applicants who have completed their university degrees from Pakistan, must submit an application to the Higher Educational Commission (HEC) in Pakistan. Once the transcript (s) and diploma (s) have a HEC stamp, the documents must be uploaded to the application portal within 15 January 2024 as document 4, in addition to the copies of the original educational documents. The degree certificates/ diploma (s), and all the pages of the transcript of records must be certified by HEC and sent directly from HEC to us. In addition, the certified educational documents at bachelor's and master's level must be sent as hard copies directly from the educational institution (s) where the education has been completed by post to HiMolde at latest within 1 March 2024 (see also below). Without these documents the application might be rejected.
- Applicants who have completed their university education in Cameroon, Eritrea, Ethiopia, Ghana, Nigeria, Sudan, Bangladesh, Nepal, India, Pakistan**, P. R of China*, the Philippines, and the US, must in addition to uploading of educational documents online with their online applications, also send their educational documents as hard copies by post directly from the higher educational institution (s) where the education has been completed, and at latest within 1 March 2024 (Last postal deadline). If HiMolde is not receiving these additional documents within this deadline, the application might be rejected because it is not complete.
