In order for HiMolde to identify applicants who might be given exemption from paying the full tuition fees, we will ask you to fill in the following questions:

I have a permanent residence permit in Norway and can document this permit.

I have a valid residence permit in Norway as a refugee, for protection or strong humanitarian reasons, and can document this permit.

I have a family reunification residence permit in Norway as a spouse/ cohabitant with common children or as a partner of a Norwegian citizen, where we both are staying together in Norway.

I have a family reunification residence permit in Norway with a spouse who is a Norwegian citizen or a citizen of a country within EU/EEA or Switzerland with a registration certificate in Norway, and where my spouse is not an international student in Norway. I am staying together with my spouse in Norway.

I have a family reunification residence permit in Norway with a spouse who is a citizen of a country outside EU/EEA and Switzerland, and where my spouse has another type of permit than a student residence permit in Norway. I am staying together with my spouse in Norway.

I have for a continuous period of 24 months had full-time work permit in Norway, and have worked and lived here, and paid tax to Norway throughout this period. International students with a part-time work permit beside their full-time studies do not fall within this category. The same with their family members who have family reunification residence permit with a spouse who is a student in Norway.

I have continuously been a self-sponsored full-time student for at least 3 years (at bachelor's level) in Norway, directly before my planned start of the MSc program at HiMolde. There can be no gap between my previous 3 years full-time studies in Norway, and the planned MSc degree at HiMolde, and during the 3 years full-time studies I cannot have obtained any other public educational support in Norway (exemptions from paying the tuition fee that fall within this category will need further and more careful evaluation by HiMolde).

□ Exchange students from the home institution who intend to take one or two semesters as part of the MSc program applied for/ or as part of a MSc degree at the home institution, and who at the same time are recruited or will be recruited within a formal collaboration agreement signed between their home institution and HiMolde might be evaluated for an exemption from paying the tuition fee. This category does not apply to applicants who intend to take all the four semesters of the MSc program applied for at HiMolde.

□ Exchange students who take one or two semesters as part of the MSc program applied for, through a partnership collaboration agreement will be further evaluated by HiMolde for exemption from paying full tuition fee. If you want us to evaluate your application for such exemption, you should cross here, and we will come back to you with further information, and documentation requirements, if we find that you might be exempted within this category. Applicants who are participating in a formal dual degree collaboration between the home institution and HiMolde might also be evaluated for exemption from paying the tuition fee, but not if they intend to take all the four semesters of the MSc program at HiMolde.
